

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to reynoldtech.com and ReynoldTech, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to ReynoldTech, LLC include reynoldtech.com. The ReynoldTech, LLC website is a Online App Usage, News and Information, Ecommerce site. By using the ReynoldTech, LLC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, ReynoldTech, LLC may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through ReynoldTech, LLC's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Use of your Personal Information

Sharing Information with Third Parties

ReynoldTech, LLC does not sell, rent or lease its customer lists to third parties.

ReynoldTech, LLC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to ReynoldTech, LLC, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by ReynoldTech, LLC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the ReynoldTech, LLC website.

Use of Cookies

- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

ReynoldTech, LLC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
